

LAND PRIME Roulette Promotion

Terms & Conditions

Land Prime is running the “Roulette Promotion” (the “Promotion”) and invites eligible new clients to participate. By participating in the Promotion, each participant agrees to be bound by these Terms and Conditions (the “Terms”).

GENERAL RULES

1. The Promotion is available exclusively to new clients who reside in Vietnam, register with Land Prime, open an eligible trading account and complete the applicable verification requirements during the Promotion Period.
2. The Promotion Period is from 3 September 2026 to 30 September 2026 at 23:59 (GMT+7). Unless otherwise stated, all dates and times in these Terms are based on GMT+7.
3. Eligible clients will be automatically enrolled in the Promotion without a separate application or opt-in.
4. The Promotion is available only for Standard and Cent Accounts. Copy and ECN Accounts are excluded. The first eligible Standard or Cent Account opened by the client after registration will be designated as the Promotion Account and Reward Account. Only one Promotion Account is permitted per client.
5. Clients may earn Roulette Tickets by completing the PRIME START, FIRST MOVE and FIRST TRADE missions and through TICKET BOOST. Each basic mission is eligible for one Roulette Ticket only.
6. The PRIME START mission is completed when the client opens an eligible trading account and completes KYC verification. One Roulette Ticket will be awarded upon completion of both requirements.
7. The FIRST MOVE mission is completed when cumulative deposits into the Promotion Account reach USD 100 during the Promotion Period. Multiple deposits may be combined. One Roulette Ticket will be awarded once only.
8. The FIRST TRADE mission becomes available after FIRST MOVE has been completed. Only trades opened after completion of FIRST MOVE will count toward this mission. FIRST TRADE is completed when cumulative eligible Trading Volume reaches 0.5 lot. Multiple eligible trades may be combined. One Roulette Ticket will be awarded once only.
9. Only eligible trades in Forex and Gold instruments will count toward the FIRST TRADE and PRIME FINISH Trading Volume requirements. Silver, Gold Mini, other Commodities, Stocks and Cryptocurrencies are excluded.
10. For TICKET BOOST, the USD 100 used to complete FIRST MOVE is excluded. One additional Roulette Ticket will be awarded whenever the client's additional Net Deposit reaches a new USD 200 threshold. Net Deposit is calculated as total deposits minus total withdrawals during the Promotion Period. Tickets already awarded will not be revoked if Net Deposit later decreases; however, a previously rewarded threshold will not be rewarded again following a withdrawal and subsequent redeposit.
11. One Roulette Ticket is required for each Roulette spin. All unused Roulette Tickets expire at 23:59 (GMT+7) on 30 September 2026 and cannot be used, restored, transferred or exchanged for cash after expiration.

12. Each eligible Roulette spin will receive a reward. Rewards may include Bonus, vouchers or physical prizes, subject to the applicable reward conditions. Rewards are non-transferable and cannot be exchanged for another reward or cash unless otherwise determined by Land Prime. Clients may be required to provide accurate information within the specified period to receive a physical prize or voucher.

13. The final PRIME FINISH Tier will be determined using the client's Net Deposit and cumulative eligible Trading Volume as of 23:59 (GMT+7) on 30 September 2026. The client must satisfy both requirements for the applicable Tier, and the highest Tier for which both requirements are met will apply. Any Tier displayed during the Promotion Period is provisional and may change according to deposits, withdrawals and trading activity.

14. Eligible clients will be individually notified of their final PRIME FINISH results by 10 October 2026 via the email address registered with Land Prime.

15. Accounts participating in this Promotion are not eligible for any other Land Prime promotion unless Land Prime expressly states otherwise.

16. Clients referred by or associated with a PAMM/MAM or Money Manager are not eligible to participate in the Promotion.

GENERAL CONDITIONS

17.1 Land Prime may disqualify any participant who abuses the Promotion, manipulates the ticket or reward mechanism, engages in fraudulent or abnormal trading activity, provides false information, or otherwise breaches these Terms.

17.2 Where Land Prime reasonably suspects fraud, abuse or a breach of these Terms, it may, subject to applicable law, withhold or cancel affected Roulette Tickets, Bonuses or Rewards; suspend related withdrawals while a review is conducted; reverse benefits obtained through the prohibited activity; or restrict or terminate the relevant account or services.

17.3 Land Prime may cancel profits or Introducing Broker commissions directly attributable to fraudulent, abusive or prohibited activity, subject to applicable law and the applicable client agreement.

17.4 Land Prime reserves the right to amend, suspend or terminate the Promotion where reasonably necessary, subject to applicable law. Any material change will be communicated through an appropriate Land Prime channel.

17.5 Land Prime reserves the right of final interpretation of the Promotion, subject to applicable law.
